

## **SUPREME ASSEMBLY DRESS CODE POLICY**

To have a standardized dress code that is tasteful, modern, classy and sophisticated with limited black to be equally enforced.

## **GENERAL APPEARANCE**

Proper under garments must always be worn and NOT visible.

All plain white or skin tone under garments must be worn under white clothing.

Nylons are suggested when wearing formal attire.

Clogs, athletic shoes and flip flops are not considered “dress shoes.”

Body piercing jewels (other than earrings) should not be worn at Rainbow functions.

All tattoos should be properly covered at all Rainbow functions.

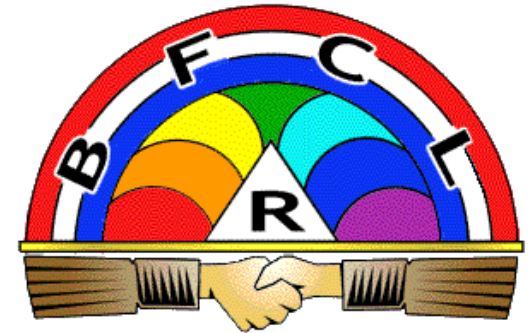

# Grand Assembly of Florida Dress Code

## **RAINBOW MEETINGS**

**Females:** Dress, shirt and skirt may be worn of any color. Your choice must look and be considered tasteful and appropriate. No more than 50% black on one outfit.

Length of dress or skirt should be no higher than two inches above the knee.

Dress shoes must be worn.

**Males:** Dress pants with dress shirt or polo shirt.

### **Attire that is not appropriate:**

Jeans, pants, skorts, mini-skirts, capris, t-shirts, tube tops or halter tops.

## **INSTALLATIONS**

**Members and Advisors:** Follow parameters identified as formal attire for initiations.

## **INITIATIONS**

**Members:** Formal dress. Your choice must be considered tasteful and appropriate (not revealing in any way). Dress may be of any color except black with a strap and with limited open back. Back of dress should not fall below the natural bra line. Slit in dress may not exceed the knee. Dress shoes must be worn.

**Candidates:** A church like dress or skirt is appropriate. Dress may be of any color except black. Dress shoes must be worn.

### **Advisors and Guests:**


**Females:** Dress or Skirt and blouse. Mother Advisors must be in a formal dress.

**Males:** Dress pants with dress shirt and tie. Jacket is optional. Dress shoes must be worn.

## **OTHER RAINBOW FUNCTIONS**

**Casual Functions:** Jeans and shorts may be worn. No short shorts.

**Swimming:** Bathing suits may be one piece or two piece providing the suit is in good taste and not revealing. In hotels and other facilities, cover-ups and appropriate shoes must be worn when traveling to and from the pool.
